I, Alan Hal Hoyle, declare as follows, with the following evidence, that Hillary Rodham Clinton has committed PERJURY, and TREASON, and that I hold you to YOUR Oath of office to uphold the Law and the Constitution of the United States of America and that I am filing Criminal Complaints and Charges in this Affidavit, Affidavit of Inquiry; and Poverty Affidavit of which requires you to take Legal Action:

And the United States of America recognizes the Almighty Yahovah and the Holy Bible in the Declaration, the Constitution, the Laws of the Land, on our money, on our buildings and in many other areas.

Whereas, in 2009 US Secretary of State Hillary Rodham Clinton signed the Classified Information Non-Disclosure Agreement.

27 April 2011 British Prime Minister Tony Blair sent classified information discussing Palestinian issues to Secretary of State Hillary Rodham Clinton's personal unsecure email account.

Whereas, on 28 June 2011 Secretary of State Hillary Rodham Clinton signed an Official Correspondence advising all State Department employees stating that, "Due to recent targeting of personal e-mail accounts by online adversaries, State employees should avoid conducting official Department business from their personal e-mail accounts."

On 28 & 29 July 2012 Bryan Pagliano, Sec. of State Hillary R. Clinton's IT technician worked on her email server working on "Mailbox Corruption", "Viruses and Attacks".

In December 2014 Hillary Clinton stated that she had turned over all documents of her personal email system consisting of 55,000 documents over to the State Department and that this was all of them. Also in 2015 responding to a court order that she again stated she had turned all Federal records and documents over to the State Department. But then in 2017 FBI uncovered 72,000

pages of documents that Hillary R. Clinton had not turned over to the State Department, but that she had also had attempted to delete.

Also in August 2015 FBI Counterintelligence Division found on then Sec. of State Hillary R Clinton's email server, of looking at just 40 of the 30,000 emails that 10% of the 40, 4 emails were classified. As NC Senator Richard Burr stated in a letter that these classified emails were of secret classification.

Article. III.

Section. 3.

Treason against the united States, shall consist only in levying War against them, or in adhering to their Enemies, giving them Aid and Comfort. No Person shall be convicted of Treason unless on the Testimony of two Witnesses to the same overt Act, or on Confession in open Court.

18 U.S. Code § 2381.Treason

Whoever, owing allegiance to the united States, levies war against them or adheres to their enemies, giving them aid and comfort within the united States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the united States.

18 U.S. Code § 1621.Perjury generally

Whoever—

(1)

having taken an oath before a competent tribunal, officer, or person, in any case in which a law of the united States authorizes an oath to be administered, that he will testify, declare, depose, or certify truly, or that any written testimony, declaration, deposition, or certificate by him subscribed, is true, willfully and contrary to such oath states or subscribes any material matter which he does not believe to be true; or

(2)

in any declaration, certificate, verification, or [statement](#) under penalty of perjury as permitted under [section 1746 of title 28, United States Code](#), willfully subscribes as true any material matter which he does not believe to be true;

is guilty of perjury and shall, except as otherwise expressly provided by law, be fined under this title or imprisoned not more than five years, or both. This section is applicable whether the [statement](#) or subscription is made within or without the united States.

- " failure to execute the laws faithfully is a high crime and misdemeanor. systematic faithlessness in this regard imperils our system and our liberties "...[T]he Framers appropriate response to corruption, lawlessness, and infidelity to the Constitution."
- "The legal grounds — provable high crimes and misdemeanors — are vital to building a political, treason, bribery, or other high crimes and misdemeanors
- "Violating her constitutional oath faithfully to execute the office of Sec. of State of the united States."
- "Violating her constitutional duty to take care that the laws be faithfully executed."
- "Making or causing to be made false or misleading public statements for the purpose of deceiving the people of the United States."
- "Preventing, obstructing, and impeding the administration of justice."
- "Withholding relevant and material evidence or information from lawfully authorized investigative officers and employees of the United States."
- "Approving, condoning, and acquiescing in obtaining the silence or influencing the testimony of witnesses or potential witnesses."
- initiated or conducted in a discriminatory manner."
- "Misusing federal agencies and executive personnel, in violation or disregard of the constitutional rights of citizens, by directing or authorizing such agencies or personnel to conduct or continue electronic surveillance or other investigations of private citizens for purposes unrelated to national security, the enforcement of laws, or any other lawful function of her office."
- "Acting in a manner contrary to her trust as Sec. of State and subversive of constitutional government, to the manifest injury of the people of the United States."

The final — most emphatic — charge (mentioned earlier) focused on *obstruction of justice*,

The greater scale that reveals an ***ongoing pattern of unprecedented deception, deceit, and betrayal.***

Therefore, be it also resolved that I do hereby demand the arrest of Hillary Rodham Clinton for her Perjury and Treason in giving aid to the enemies of our Country, that Due Process will be started for the criminal acts stated herein with her blatant disregard for the security of our Nation for her misuse of her emails.

I, Alan Hal Hoyle, declare as follows:

I declare under penalty of perjury that the above and foregoing statements are true and correct to the best of my information, knowledge, and belief.

And in all indictments for libels the jury shall have the right to determine the law and the facts, under the direction of the court, as in other cases.
